1. Go to https://www.finance360.org/vendor/vendorportal and enter your 9-digit Federal Tax ID.

2. Click on the Register.

The Administrator has the authority to grant access to an additional user(s) who need access to the CMT. Each user will manage their own account information, but the Administrator will perform the initial setup and grant permission to other users.]
